 - A guide to formation of self-help groups in low-income coun-

tries that also will be of interest in high-income countries. Though many of the examples used are from low-income countries, the principles outlined along with strategies of development and organizational considerations are universal.

This history describes the antecedents to DPI 's formation, and the organization's growing pains as well as accomplishments during its first five years.

Canada: author, 1992, 87pp.

This report presents 13 abbreviated papers, 12 statements of personal perspective, and 6 reports from the 3rd World Congress of DPI. Presentations are from a broad cross-section of the world within the disability movement including Henry Enns, Fatima Shah, Joshua Malinga, Rachel Hurst, Huntley Forrester, Justin Dart and others, and cover a wide range of issues related to achieving equal opportunities.

Neufeldt, A.H. (Ed.), *Independent living: an agenda for the 90s.* (Ottawa: Canadian Assoc. of Independent Living Centres, 1993) 140 pp.

Twelve papers addressing key issues in the independent living movement such as: advocacy, consumer control, future trends impacting the independent living movement, and an agenda for the '90s focussing on disability rights.

Attitude, discrimination and rights

Boylan, E. Women and disabilility. (London/New Jersey: Zed Books Ltd, 1991) 111 pp.

Part of the "Women and World Development" Series which focuses on issues pertinent to women with disabilities in developing countries. Particular areas of concern addressed are stigma, the influence of traditional practices on disability, education, employment, human rights, aging and disabled, and innovative rehabilitation programmes in various countries.

Driedger, D. and Gray, S. *Imprinting our image: an international anthology by women with disabilities*. (Charlottetown, PEI: Gynergy Books, 1990) 160 pp. A collection of essays, poems and commentary on the experience of disabled women as the subjects of discrimination.

rience of disabled women as the subjects of discrimination. Contributions come from Africa, Asia, Europe, North America, Central and South America and the Caribbean

Finkelstein, Victor. *Attitudes and disabled people* (New York: World Rehabilitation Fund, 1980) 92 pp.

The first half of the monograph sets out one of the first detailed critiques of the construct of "disability". While the

analysis of history provided is open to criticism, the strength of the monograph is in its logical argumentation on the role of social attitudes in defining disability. The second half of the monograph provides four commentaries from U.S. authors. Though somewhat dated now, this monograph still is a useful resource in examining disability as a social construct.

Foucault, M. Madness and civilization. (New York: Random House, Vintage Books Division, 1973) 299 pp.
Foucault traces the history of perceptions of insanity from the Middle Ages to the nineteenth century, and the social forces which led to the creation of places of confinement.

Wolfensberger, W. "The origin and nature of our institutional models." In, R.B.Kugel and W. Wolfensberger (eds.). Changing patterns in residential services for the mentally retarded. (Washington: President's Committee on Mental Retardation, 1969):59-172. A detailed analysis of the social models of "mental retardation" (sic) in nineteenth and twentieth century North America, their dehumanizing dimensions, and their impact on the development of residential institutions.

Wolfensberger, W. The principle of normalization in human services (Toronto: National Institute on Mental Retardation [now, the G. Allan Roeher Institute] 1972) 258 pp.

The normalization principle is presented as a guiding construct to counter the prevailing negative social perceptions of disabled people as reflected in human services. This principle was first transformed into social policy in Sweden and Denmark, and subsequently in Canada and the USA. The normalization principle continues to have an impact on social policy, though Wolfensberger himself has reconceptualized the construct into "social role valorization."

Physical abuses and persons with disabilities

Baladerian, N.J., "Sexual abuse of people with developmental disabilities." In *Sexuality and Disability*, 9 (4)(1991):323-335. A review of the prevalence and incidence of sexual abuse,

with an analysis of current data collection methodology, treatment and recommendations.

Sobsey, D. and Doe, T. "Patterns of sexual abuse and assault." In Sexuality and Disability, 9 (3)(1991): 243-259.

A comprehensive analysis of 162 reports regarding the sexual abuse of people with disabilities. Incidence, prevalence and treatment programs are outlined, as well as implications relating to the low conviction rate of offenders. Included in the report is a multifactorial, ecological model of abuse and recommendations for possible prevention strategies.

Sobsey, D. "The research that shattered the myths: understanding the incidence and nature of abuse and abusers." In the *NADD Newsletter*, 11, (3):1-4.

An examination of the erroneous myths attached to the sexual abuse of people with disabilities.

Rights of disabled people and public policy

Bickenbach, J. *Physical disability and public policy.* (Toronto: Univ. of Toronto Press, 1993) 327 pp.

An examination of various models of disability (biomedical, economic, social, political), normative bases of disablement theory, and discussion of equality approaches to public policy.

Foley, C. and Prattin, S. *Access denied: human rights and disabled people.* Consultation with BCODP; (London: National Council for Civil Liberties, 1994) 68 pp.

A joint publication between Liberty and the BCODP examining the lack of human rights for disabled people in the United Kingdom. Attention is given to the government 's record of human rights, the International Covenant on Civil and Political Rights, access, media and employment discrimination.

Hahn, H., "Towards a politics of disability:definitions, disciplines and politics," *The Social Science Journal* 22 (4) (1985): 87-105.

An examination of the various (approaches underlying) definitions of disability and its implications for policy making.

Haveman, R.R., V. Halberstadt and R.V. Burkhauser, *Public Policy Toward Disabled Workers: Cross-National Analyses of Economic Impacts* (Ithaca and London: Cornell University Press, 1984) 583 pp.

An analysis of economic approaches to public policy and disability in the USA and six European countries.

Neufeldt, A.H., C. Stoelting & B. Fraser. *Economic independence* for persons with disabilities: a background paper. Prepared for Employment and Industry Canada (Calgary: A. H. Neufeldt and Associates, 1991) 24 pp.

Analysis of the discriminating effect of current policies on disabled persons in Canada as it effects their participation in the labour force. Based on secondary analysis of Statistics Canada data.

Neufeldt, A.H. and S. Friio. *Rights, equity and employment of disabled persons in Canada*. Discussion paper prepared for Expert Meeting titled: "Mandatory Employment or Equal Opportunities? Employment Policies for People with Disabilities in the UN-European Region." Vienna: European Centre for Social Welfare Policy and Research, Dec. 1 -2, 1994, Paper No. 2, 14 pp.

Analysis of progress in employment of disabled persons in Canada in the context of the Canadian Charter of Rights and employment equity legislation.

Rioux, M. "Labelled disabled and wanting to work." In, Judge R. S. Abella, Commissioner (1984). *Equality in employment—a Royal Commission Report;* Research Studies Supplement (Ottawa: Supply and Services, 1984):613-614.

The Abella Report established the basis for employment equity legislation in Canada, taking its direction from the *Canadian Charter of Rights and Freedoms* adopted in 1982. The *Charter* is the highest law in the land in that all federal and provincial laws are subject to interpretation under it. The *Charter* includes disabled people as a designated group not to be discriminated against. A supplement to the Abella Report includes this contribution by Rioux which sets out the argument that disabled Canadians are discriminated against in the labor force.

Roeher Institute. *On target? Canada's employment-related programs for persons with disabilities.* (North York: Author, 1992) 241 pp.

An analysis of Canada 's employment related programs for disabled persons and discriminatory features.

Sobsey, D. "Disability, discrimination and the law." In *Health Law Review*, University of Alberta, 2 (1):6-10.

An article from a session on disability and the law which discusses the legal issues that surround disability law.

Journals, newsletters and magazines

Canadian Journal on Special Education. Published by Centre for Human Development and Research, Vancouver, British Columbia (since 1985).

A journal devoted to issues concerning exceptional children in education. A number of articles relate to rights to education and integration within the classroom.

Disability & Society (since 1985; started as Disability, Handicap & Society)

Critical, interdisciplinary journal on the position of disabled persons in society.

Disability International (formerly, Vox Nostra). Published by Disabled Peoples' International (since 1994). Strong emphasis on issues pertaining to the rights of disabled people. A cross-disability orientation.

Entourage. Published by Roeher Institute, Ontario (since 1986). (A merger of La Revue Canadienne de la Deficience Mentale, and Canadian Journal on Mental Retardation.) English and French.

This journal focuses on social action pertinent to disabled people in a time of political and economic change.

International Journal of Rehabilitation Research (since 1977).

Journal of the Association for the Severely Handicapped. Published by the Association for the Severely Handicapped, Se-

attle. The rights of mentally handicapped children within the U.S. education system are a central focus of concern in this journal.

Journal of Practical Approaches to Developmental Handicap. Published by Vocational and Rehabilitation Research Institute, Calgary, Alberta and the Rehabilitation Studies Program, University of Calgary, Calgary Alberta. (since 1977).

A publication concerning disability, practice and applied research in the field of Rehabilitation. Concern has focused on a broad spectrum of rights for disabled people.

Journal of Social Issues. Published by Plenum Publishing Corporation, New York (since 1945).

A quarterly publication which includes articles relating to the rights of disabled people.

Mental and Physical Disability Law Reporter. (continues *Mental Disability Law Reporter*). Published by American Bar Association, Committee on the Mentally Disabled, Washington.

A law journal pertinent to the legal aspects of insanity, jurisprudence, mental health law, physical handicap and the legal rights of disabled people.

Mental and Physical Disability Law Review (since 1986).

Rehabilitation (since 1961; in German).

Scandinavian Journal of Rehabilitation Medicine (since 1968).

Sexuality and Disability. Published by Human Sciences Press Inc., New York (since 1978).

Devoted to the study of sexuality in physical and mental illness, with coverage of issues relating to sexual abuse and human rights.

Social Science & Medicine (since 1957)

This journal does not exclusively focus on disability issues, but frequently covers related questions.
