ABOUT THE JOURNAL

Health and Human Rights began publication in 1994 under the editorship of Jonathan Mann, who was succeeded in 1997 by Sofia Gruskin. Paul Farmer, co-founder of Partners In Health, assumed the editorship in 2007. After more than a decade as a leading forum of debate on global health and rights concerns, *Health and Human Rights* moved to an online, open access publication with Volume 10, Issue Number 1, in 2008. The full text of *Health and Human Rights* is now freely available to anyone with internet access.

Health and Human Rights maintains a tradition of critical scholarship and also provides an inclusive forum for action-oriented dialogue among human rights practitioners. The “Critical Concepts” section focuses rigorous scholarly analysis on the conceptual foundations and challenges of rights discourse and action in relation to health. The “Health and Human Rights in Practice” section is dedicated to empowering new voices from the field, highlighting innovative and direct engagement with human rights as they relate to health. Complementary and mutually reinforcing, these sections seek to foster engaged scholarship and reflective activism. They invite informed action by and with communities to realize the full spectrum of human rights.

Health and Human Rights welcomes unsolicited manuscripts. Articles are invited for two peer-reviewed sections, Critical Concepts (5,000–7,000 words) and Health and Human Rights in Practice (500–7,000 words).
