The overriding mission of the School—to advance the public's health through learning and discovery—comprises four objectives: to educate scientists, professionals, and leaders of public health; to foster new discoveries and develop better technologies for improved health of individuals and populations; to inform and influence debate on key public health issues; and to strengthen capacities and services that meet health needs in the community.

ASSOCIATION FRANÇOIS-XAVIER BAGNOUD

The Association François-Xavier Bagnoud currently supports worldwide programs in humanitarian assistance, aerospace research for the benefit of people, and community life in the Swiss canton of Valais. Humanitarian assistance focuses on children's rights—especially the right to health care—of children who are orphaned, abandoned or sick, many of whom have AIDS or are HIV-infected. Projects are located in Thailand, India, Switzerland, Kenya, Uganda, Uruguay, Columbia, and the United States. The Association François-Xavier Bagnoud bears the name of a young Swiss helicopter rescue pilot who died in a helicopter accident while flying over the desert in the African country of Mali in 1986.

Health and Human Rights welcomes unsolicited manuscripts. Authors interested in being published in *Health and Human Rights* should send their manuscripts to the Managing Editor at the address above. Manuscripts should be typed, double-spaced, submitted in triplicate, and accompanied by a computer diskette, preferably in Microsoft Word 5.0 word processing format. Detailed guidelines for contributors may be obtained by writing or calling the address above .

Views expressed in the journal are those of the authors and do not necessarily reflect the views of *Health and Human Rights'* officers, editors, or other members.

Subscriptions

The annual domestic Subscription Rates for *Health and Human Rights* are US\$36 for one year, US\$68 for two, and US\$95 for three years. The Institutional Rates are US\$80 for one year, two years US\$150, three years US\$210. The Student Rates are US\$24 for one year, US\$42 for two years, and US\$64 for three years. Individuals may also wish to subscribe at the Sponsorship Rate of US\$48 for one year, US\$85 for two years, and US\$127 for three years. The Sponsorship Rates help subsidize free distribution of *Health and Human Rights* in developing countries. International subscribers add US\$8 per year. Canadian subscribers add US\$5.20 per year plus GST. The cost of each individual issue is US\$12.
